

What Does the Evidence Tell Ohio?



Kids with the most complex multisystem needs **require a very different type of care coordination.**

Studies show that **intensive community-based care coordination** that is driven by kids and their families can have a significant impact on inpatient and emergency department (ED) use, moves between homes, family engagement and satisfaction, and life outcomes. Kids with the most complex multi-system needs require a **different service array** to stabilize them within their families.



Mobile crisis response, intensive home-based treatments, and out of home care **ONLY when clinically appropriate.**








High Fidelity Wraparound


In Wraparound, a dedicated Care Coordinator coordinates the work of system partners and other natural helpers so there is one coordinated plan.







Care Coordination is Guided by High Fidelity Wraparound Principles



All tiers – CANS due every 90 days or if there is a change or significant life event.



Roles of Care Management Entities (CMEs)





- In addition to individual work with youth and caregivers, the CMEs will work with community partners (service providers, public child serving agencies and other stakeholders) to develop the local system of care.
- CMEs will be culturally and linguistically competent, with agencies, programs, and care coordination services that reflect the cultural, racial, ethnic, and linguistic differences of the populations they serve to facilitate access to and utilization of appropriate services and supports and to eliminate disparities in care.

OhioRISE Eligibility

Children must meet all of the criteria below

Medicaid Eligible

- Fee for service or managed care
- May also have an existing 1915(c) waiver – Intellectual/Developmental Disability, Ohio Home Care, etc.

Age 0-20 at time of enrollment

Require Significant and Intensive Behavioral Health Treatment

- Meet Functional Needs Criteria as assessed by the Child and Adolescent Needs and Strengths (CANS); or
- An inpatient in a hospital for mental illness or Substance Use Disorder (SUD); or
- An inpatient in a Psychiatric Residential Treatment Facility (PRTF)

ODM anticipates OhioRISE will enroll 50,000 to 60,000 children and youth by the end of the first year







Options for Initiating a Referral to OhioRISE / CANS Assessment

Contact the youth's MCO directly.

Department of Medicaid

- MCO must ensure an initial CANS assessment appointment for the purpose of determining OhioRISE eligibility is scheduled within 72 hours of referral to the MCO.
- The MCO must have a process in place to ensure the initial CANS assessment is completed within 10 business days after scheduling.






What is a CANS Assessment?

The **Child and Adolescent Needs and Strengths (CANS)** is a functional assessment tool that:

- Assesses both child and family needs and strengths
- Provides decision support to identify appropriate approaches
- Used to make OhioRISE program eligibility determinations
- Used to support OhioRISE care planning




Why You Should have a CANS Assessor on Staff

- To be prepared to support youth and families who may benefit from OhioRISE, pediatricians may want to have at least one staff member certified in the Ohio Children's Initiative CANS who can conduct assessments and submit results to the CANS IT System
- Children and youth who may benefit from OhioRISE: »Have multiple needs that result from behavioral health challenges »Have multi-system needs or are at risk for deeper system involvement »Are at risk of out-of-home placement or are returning to their families from out-of-home placement
- Rather than referring a youth and family elsewhere for a CANS assessment, you may want to provide an assessment to
 ensure families don't need to work with another provider at a later date. Many youth and families that could benefit
 from OhioRISE have urgent needs.
- CANS Assessment Certification is available to anyone in Ohio
 - » Cost of training and certification is covered by the Ohio Department of Medicaid
 - » No clinical background required
 - » Attend a live virtual training session (6 hours) through the Child and Adolescent Behavioral Health Center of Excellence (COE). Find a training <u>here</u>.
 - » Pass an online certification exam through the Praed Foundation
 - » Get CEUs for completing the training
 - » Reimbursement for completing CANS assessments is available for enrolled Medicaid providers with the CANS specialty. Find more 19 information about enrollment and billing <u>here</u>.



What is the CANS Information Technology System?



Department of Medicaid

Centralized System for documenting CANS assessments and reassessments/updates with a youth/caregiver. Certified Ohio Children's Initiative CANS assessors will register and use the system to document these assessments in a single location.

Supports our **cross-system goal of "one child, one CANS"** and ensures that youth/caregivers do not need to retell their stories.

Improves care continuity and collaboration. Outputs/results are accessible to assessors and care team members, promoting cross-system coordination in real-time.

Assessments must be submitted into the IT System to enroll youth into OhioRISE including when there is a behavioral health inpatient stay

Produces **immediate Decision Support Model outputs**, including care coordination and care recommendations.

Track trends and outcomes to identify gaps and inform access and capacity improvement efforts.






The CANS IT System Initiates Rolling Enrollment into OhioRISE

OhioRISE enrollment is triggered by one of the following actions in the CANS IT System:

- Notification of an Inpatient Psychiatric/PRTF admission
- Submission of a CANS assessment by a certified assessor (either Brief or Comprehensive)







How do I identify my patient's OhioRISE Care Coordinator?



Reminder:

- ✓ Aetna Care Coordinators provide Limited Care Coordination (Tier 1)
- ✓ Care Management Entities (CMEs) provide Moderate Care Coordination (Tier 2) and Intensive Care Coordination (Tier 3)





Members may decline OhioRISE Care Coordination



Scenario 1: When members do not want to engage in OhioRISE Care Coordination

Scenario 2: When members elect to receive coordination elsewhere (i.e. Family and Children First Council) and do not want OhioRISE CC

An OhioRISE Care Coordinator from Aetna will remain available to:

- Engage with primary care coordination entity, coordinator, or a key person involved with youth and family ("youth's trusted advisor")
- ✓ Gather appropriate Release of Information (ROI) and consents (takeaway---arm Service and Support Administrator (SSA) and FCFC with these forms)

- ✓ Complete 30-day outreach
- ✓ Secure the child and family-centered care plan (CFCP) for waiver members
- ✓ Ensure completion of 90-day CANS Assessment
- ✓ Support completion of a Health Risk Assessment (HRA) for an MCO or OhioRISE Plan
- ✓ Authorize and pay for services
- ✓ Ensure referrals to MCO transportation, services, benefits
- ✓ Engage with family regarding services, as appropriate
- ✓ Issue required member materials





What do I need to do once my patient is enrolled in OhioRISE?

Be prepared to talk with youth and families about the OhioRISE program



An OhioRISE Care Coordinator will contact you to learn about your work with the youth and their family

- You will be invited to participate in your patient's Child and Family Team (CFT) meetings
 - » The CFT develops the Child and Family-Centered Care Plan which outlines services and supports for the youth and family and meets:
 - Every 30 days for youth in Intensive Care Coordination (Tier 3);
 - Every 60 days for youth in Moderate Care Coordination (Tier 2) and Limited Care Coordination (Tier 1); or
 - Whenever there is a significant change in a member's condition or circumstances
 - » The CFT is responsible for identifying any needed services and supports
 - Treatment services must be documented on the Child and Family-Centered Care Plan





What do I need to do once my patient is enrolled in OhioRISE?



Understand what services and supports are covered through OhioRISE

- » Many of the new or enhanced OhioRISE services are *only* covered when a youth is enrolled in OhioRISE
 - Intensive Home-Based Treatment (IHBT)
 - Psychiatric Residential Treatment Facility (PRTF)
 - Behavioral Health Respite
 - Primary Flex Funds
 - OhioRISE 1915(c) waiver services (requires waiver enrollment)
- » It is important for providers to work closely with the Child and Family Team when new or different services are recommended to ensure approval and coverage



- » A behavioral health provider or Family and Children First Council that has a CANS assessor onsite.







OhioRISE Overview for Community Partners

What are the basics of OhioRISE?

OhioRISE is a specialized Medicaid managed care program for children and youth with complex behavioral health needs (mental health/substance use disorder) and multi-system needs. Aetna Better Health of Ohio (Aetna) is the managed care partner for the program.

Children and youth with multi-system needs are often involved in multiple community systems such as juvenile justice, child protection, developmental disabilities, education, mental health and addiction, and others.

The OhioRISE Program uses a "system of care" approach and the guiding principles of a wraparound philosophy. These techniques focus on "wrapping around" a child or youth through care coordination to provide services and supports through a coordinated network in their community. This helps ensure the child or youth functions better at home, in school, in the community, and throughout life.

OhioRISE care coordination uses a Child and Family Team (CFT) approach. Children or youth and their caregivers select members of their CFT. The CFT meets regularly to assist with care planning that focuses on the child or youth's and family's strengths, beliefs, culture, community/natural supports, and their voice and choice. OhioRISE care coordination is provided at three levels of intensity:

- » Limited Care Coordination (Tier 1) delivered by Aetna and is the least intensive level.
- » Moderate Care Coordination (Tier 2) delivered by Care Management Entities (CMEs) and uses wraparound-informed strategies.
- » Intensive Care Coordination (Tier 3) delivered by CMEs and adheres to the High-Fidelity Wrap Around model.

A child or youth's CANS assessment will be stored in the CANS IT System and will be updated regularly to track progress and help with ongoing care planning. Who is eligible for OhioRISE?

How might OhioRISE help children and youth receiving MRSS?

MRSS provides children and youth in crisis and their caregiver(s) with immediate behavioral health services. All children and youth who receive MRSS will be provided a CANS assessment to help determine their needs and strengths and to assist in planning follow-up care.

The CANS assessment can also be used to see if a young person is eligible for OhioRISE.

OhioRISE Members are Excluded from CPC Attribution and Reporting

- » Per Ohio Administrative Code 5160-19-01(B)(1), "Attributed medicaid individuals" are Ohio medicaid recipients for whom PCPs have accountability under a PCMH. A PCP's attributed medicaid individuals are determined by ODM or medicaid managed care organizations (MCOs). All medicaid recipients are attributed except for:
 - (a) Recipients dually enrolled in Ohio medicaid and medicare;
 - (b) Recipients not eligible for the full range of medicaid benefits; and
 - (c) Recipients with third party benefits as defined in rule 5160-1-08 of the Administrative Code except for recipients with exclusively third party dental or vision coverage.
 - (d) Recipients enrolled in a prepaid inpatient health plan, as defined in 42 C.F.R. 438.2 (as in effect on October 1, 2021), under contract with ODM."
